Job Insurance

Eventually this election season will end and another will start. There will be another politician attempting to chip away at our wages, benefits and working conditions. Recent attempts have been made to end six day delivery and door to door delivery. If five day delivery had been legislated there would be about thirty thousand less city carriers on the street. I do not know the impact of cancelling door to door delivery. We must be vigilant in watching what happens on Capitol Hill and 1600 Pennsylvania Avenue. Recently, Congress required new federal employees to pay towards their retirement, the 1 percent per year of service annuity. Those employees hired in 2013 pay 3.1 percent and those hired in 2014 and after pay 4.4 percent. These increases do not increase the employee's benefits in any way. The increase in contribution amount is a pay cut. This is one example of how those individuals who roam the Halls of Congress affect your wages. Congress has also floated the idea that federal employees do not need a Union. Imagine the work floor environment if we all were not protected by a Collective Bargaining Agreement; it would multiply the abuses of letter carriers that occur regularly without grievance or consequence. This is where the Letter Carrier Political Fund helps to protect and preserve our wages and benefits. The Letter Carrier Political Fund pays to have letter carriers released from their postal duties to work with AFL-CIO affiliated campaigns. This would include candidates for the House, Senate and President. The released letter carriers would conduct voter outreach via telephone or door to door contact. Then as Election Day approaches their attention would turn to voter turnout. Your contribution would be going to pay their salary. Then there are the usual campaign contributions to candidates for office donation. The donations help our legislative liaisons in their attempt to get the candidate to agree with our issues. Those congressional allies we support that have crossed party lines have helped us fight off numerous attempts to end Saturday delivery. The Letter Carrier Political fund has made donations to Democrats, Republicans and Independents. The notion that we only give to democrats is wrong. Our National Union leaders have cultivated relationships with members of both parties. This phenomenon is not an accident.

The proof is in the number of Republican cosponsors for House Resolution 12, this is for maintaining 6 day delivery and House Resolution 54 to reinstate the service standards prior to 2012. There are 60 Republican cosponsors to H.R. 12 and 52 for H.R. 54. Our National Union leaders work tirelessly to improve our wages, benefits and working conditions. The vehicle for them to be able to influence our elected officials is our Letter Carrier Political Fund. We letter Carriers as individuals cannot match the ability of billionaires to pour their millions into campaigns, but by each of us giving as little as \$5.00 per pay we can level the playing field and be able to maintain our wages and benefits. I know there are some letter carriers who are not comfortable giving but we have to look at where we would be without the wages and benefits this job provides us. I view a contribution to the Letter Carrier Political Fund as a form of job insurance. It is a way to help our National Union officials fight off all the attacks from not so worker friendly politicians.

As a member of the NALC, there are several easy ways to give to the Letter Carrier Political Fund:

1. **Payroll deduction:** Contribute automatically, using PostalEase (either online or by phone) to set up an allotment deduction from your USPS paycheck.

Why give to the NALC Political Fund?

Under federal law, labor unions are strictly prohibited from spending dues money on contributions or expenditures in connection with federal elections. So in 1975, the NALC established a PAC to become proactive in the electoral process.

Support for letter carriers and the Postal Service comes from all political parties, so the fund is committed to supporting pro-letter carrier candidates, regardless of their political affiliation.

Every year, our PAC grows and NALC's voice in Washington gets stronger.

By making a contribution to the National Association of Letter Carrier Political Fund, you are doing so voluntarily with the understanding that your contribution is not a condition of membership in the National Association of Letter Carriers or of employment by the Postal Service nor is it part of union dues. You may refuse to contribute without any reprisal. The Letter Carrier Political Fund will use the money it receives to contribute to candidates for federal office and undertake other political spending as permitted by law. Your selection shall remain in full force and effect until cancelled. Contributions to the Letter Carrier Political Fund are not deductible for federal income tax purposes. Federal law prohibits the Letter Carrier Political Fund from soliciting contributions from individuals who are not NALC members, executive and administrative staff or their families. Any contribution received from such an individual will be refunded to that contributor.

Open Season:

The Start date of Open Season for FEHBP (Federal Employees Health Benefits Plans)

is November 14, 2016 and ends on December 12, 2016.

City Carrier Assistant (CCA) Information:

1. You can choose self only or self and family coverage in the USPS Noncareer Plan and receive a \$125.00 contribution to the premium every two weeks.

2. As a NALC Member, you can choose to become a member & select self plus one or self and family coverage (not self-only) from the NALC Consumer Driven Plan or Value Option Plan and receive the \$125 bi-weekly contribution from USPS.

3. You can choose self-only, self plus one or self & family coverage in any plan offered through the FEBH Program -but- receive NO contribution toward premium costs.

*If you have NOT completed a 360 day period of service, YOU HAVE ONLY ONE PLAN OPTION:

1. You can choose to enroll in USPS Noncareer plan (with either self-only or family coverage) and receive the \$125 bi-weekly premium contribution from the Postal Service. HOWEVER, if the NALC prevails in its disputes with the USPS, you may also have the option in the future to choose self & family coverage under either version of the NALC Consumer Driven Plan or Value Option Plan and receive the \$125 bi-weekly contribution from USPS.

NOTE: City Carrier Assistants (CCA) should visit our website at www.nalchbp.org for information.

Once CCA's are converted to career status, they have 60 days to enroll in a FEHB Plan. The coverage of any CCA enrolled in the USPS Non-Career Employee Health Benefits Plan terminates the last day of the month that is 28 days after the conversion to career status. Coverage in a FEHB plan will begin the 1st day of the 1st pay period after Human Resources receives the employee's election for coverage.

Any carrier who does not enroll during the 1st 60 days after being converted to career will have to

wait to enroll during Open Season - UNLESS - They have a Qualifying Life Event (QLE).

Please give consideration to joining our union's health plan. Our health plan's rates and benefits are as good as or better than the other plans that are open to our members.

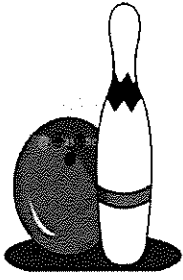

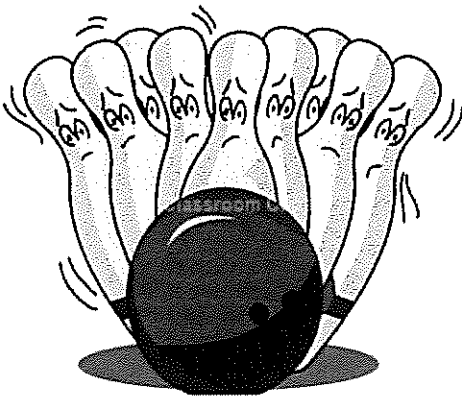
